

End User License Agreement

This is an agreement between you (as a purchaser) and Eko Bimantara (copy right holder of the fonts). In accepting the terms of this agreement, you acknowledge understanding and promise to comply with its terms.

What you are purchasing from Eko Bimantara is the license to use digital typeface software – hereafter "fonts" – on one or multiple computers within your personal or your company's or your organization's. You are not purchasing the copyright to the design of the fonts, but the rights to use the fonts.

A. License Grants

By purchasing and downloading this font software, Eko Bimantara granted you non-exclusive license to install, access and use the Fonts.

These licenses are limited based on the variation of usage and it's amount limitation within the usage of the fonts. These usage are determined and limited to the choosen license when purchasing the fonts:

1. Standard License

Desktop: 1-5 users

2. Extended License

Desktop: Up to 10 users

Web: Up to 100.000 monthly pageviews

3. Studio License

Desktop: Up to 30 Users

Web: Up to 1.000.000 monthly pageviews

ePub: Up to 5 titles

App usage allowed

4. Enterprise License

Desktop: Up to 100 Users

Web: Unlimited numbers of monthly pageviews

ePub: Up to 10 titles

Server: Up to 4 servers

App usage allowed

Broadcast usage allowed

Each license contain the scope of usage of the fonts:

Desktop Usage: Allowed to install and use fonts on computers with a number of copies limited to the number of users.

Website Usage: Allowed to use fonts for self hosting website based on the limitation of the pageviews.

App Usage: Allowed to embed the Font Software into an iOS, Android or Windows Phone application.

ePub Usage: Allowed to to embed fonts in electronic publications such as digital books, magazines, newspapers based on the number of publication titles.

Server Usage: Allowed to install the software on accessible servers for remote users based number of servers.

Broadcast Usage: Allowed to use the fonts for broadcast purposes; Video and moving image public transmission, for example; Digital signage screens, TV advertising, cinema advertising.

B. General Permission

B.1. You may make a back-up copies of the Font Software for archive purposes only.

B.2. You may edit and modify the typographic elements provided by the fonts. Please note that the copyright of the fonts still remain by Eko Bimantara.

B.3. For web usage, you can provide third party, which have a commercial cooperation with you or your company or organization, a copy of the font software for a specified project scope, only to implement the font software into websites.

B.4. For app usage, you can only embed fonts into one application only.

B.5. Usage for social media such as Youtube, Instagram, Vimeo are excluded from broadcast usage, as its covered by desktop usage.

C. General Restriction

- C.1. All fonts provided remains the intellectual property of Eko Bimantara. Therefore, you may not modify, alter, disassemble or rename the font software. This applies also to the code inside the font files.
- C.2. Selling the fonts or selling an access to the font files.
- C.3. Modifying the font files in a purpose to make a new fonts from the purchased fonts.
- C.4. Selling or distributing the modified version of the fonts.
- C.5 You need to be careful for the usage and distribution of this font files, all forms of usage are need to be protected from misuse, the font files need to be secured from accessed, extracted or taken by parties which are not related to this agreement.
- C.6. You have to ensure that the use of the fonts conforms to the limitations stated on the license that you have purchased. If your requirements exceed these limits, further payments are required to add or renew existing licenses.
- C.7. For website usage, company or organization such as an advertising agency, web design agency, or hosting provider that responsible for several of its client's websites must have separate agreements for each of the client's websites.
- C.8. Embedding Font Software into Applications need to be done in a safe manner, which does not allow End Users to access Font Software outside the Application.

D. Limitation of Liability

Eko Bimantara does not responsible for you or other third party for any damages, including lost of profits, lost of data, lost of business opportunity cause by the fonts usage.

E. Termination

This agreement will automatically terminate if you fail to comply with its terms. If any part of the EULA is found to be invalidated and cannot be implemented.
