

# End User License Agreement

Last updated: 14 April 2026

This End User License Agreement (the "Agreement") is entered into by and between you ("Licensee") and Eko Bimantara ("Licensor"), the copyright holder of the fonts. For the purposes of this agreement, 'font software' ("Fonts") refers to the digital file that includes the typeface design, its encoding, and any associated code. In accepting the terms of this Agreement, you acknowledge that you have read this Agreement, understand it and agree to be bound by its terms.

## 1. License Grant

Subject to the terms and conditions of this Agreement, Licensor hereby grants to Licensee a non-exclusive, non-transferable license to install, access and use the fonts. Licensee are not purchasing the copyright to the design of the fonts, but the rights to use the fonts. This license is granted on a one-time purchase basis and is not limited by time.

## 2. Scope of License

The license that Licensee have purchased is determined by the chosen license when purchasing the fonts at <https://ekobimantara.com/>.

## Enterprise License

**2.1 Desktop:** Allowed to install and use fonts on computers with a number of copies up to 700 users.

**2.2 End Product:** Allowed to use fonts for final result of an activity or production process, especially the finished article in a manufacturing process. This includes product packaging, prints and merchandise, also includes physical publication prints and physical advertising prints. The usage is for an unlimited number of end products.

**2.3 Website:** Allowed to use fonts for self-hosting websites for unlimited pageviews.

**2.4 Digital Ads:** Allowed to use fonts for digital ads media formats including Google, Instagram, Facebook, YouTube, TikTok and other social media channels for unlimited amounts of impressions.

**2.5 ePub:** Allowed to embed fonts in electronic publications including digital books, magazines, newspapers for unlimited number of publication titles.

**2.6 App:** Allowed to embed the fonts into an iOS, Android or Windows Phone application.

**2.7 Server:** Allowed to install fonts on accessible servers for remote users up to 4 servers.

**2.8 Broadcast:** Allowed to use fonts for large scale broadcast purposes; Video and moving image public transmission, including digital signage screens, TV advertising, cinema advertising.

**2.9 Trademark:** Allowed to register a logo that uses the fonts for trademark. Please remember that trademark registration is only for logos that use the typeface design of the font, the font software itself is still in the right

of Licensor.

### 3. Permission and Restrictions

**3.1 Ownership:** All fonts provided remain the intellectual property of Licensor. Therefore, Licensee may not modify, alter, disassemble or rename the font software. This applies also to the code inside the font files.

**3.2 Sale and Distribution:** Licensee are not allowed to sell the fonts or sell access to the font files.

**3.3 Modification:** Licensee are not allowed to modify the font software in a purpose to make new fonts from the purchased fonts.

**3.4 Distribution of Modified Version:** Licensee are not allowed to sell or distribute the modified version of the fonts.

**3.5 Backup:** Licensee may make back-up copies of the fonts for archive purposes only.

**3.6 Protection:** Licensee agree to be careful for the usage and distribution of these font files. All forms of usage need to be protected from misuse, the font files need to be secured from accessed, extracted or taken by parties which are not related to this agreement.

**3.7 Separate License:** If Licensee are a design consultant, agent, or an advertising agency, Licensee must acquire a separate license for each client utilizing the fonts, whether for internal or external purposes. Additionally, each client, acting as the end user, must obtain a license appropriate for their specific use of the fonts.

**3.8 Website usage:** Licensee may provide a third party, which has a cooperative relationship with Licensee a copy of the font software for a specified project scope, only to implement the font software into a website.

**3.9 Application usage:** Licensee may embed the fonts to application with the condition that font software embedding occurs securely within applications, preventing end users from accessing the font software outside the designated application.

#### 3.10 Extended Use by Subsidiaries and Affiliates:

Notwithstanding the non-transferable nature of this License, the Licensee is permitted to extend the use of the Font Software to its subsidiaries and affiliates, provided that such entities are under the direct ownership or control of the Licensee.

The distribution and use of the Font Software among the Licensee, its subsidiaries, and affiliates shall be collectively limited to a maximum of 700 authorized desktop users. This total includes the Licensee's own internal users and may not be exceeded without the express written consent of the Licensor.

Such extended usage shall be subject to the following conditions:

a. **Control and Responsibility:** Licensee must ensure that all subsidiaries and affiliates agree to adhere to the terms of this Agreement. The Licensee remains responsible for any breach of this Agreement by its subsidiaries or affiliates.

b. Limitations on Usage: The scope and manner of use by subsidiaries and affiliates shall be strictly limited to the purposes directly related to the Licensee's legitimate business operations and must not exceed the rights granted to the Licensee under this Agreement.

#### **4. Warranty of Ownership**

Licensor warrants that the font software is the property of the Licensor, and that the Licensor holds full rights and authority to license the font. Furthermore, the font software is free from any claims of copyright infringement or ownership disputes by third parties.

#### **5. Limitation of Liability**

In no event shall Licensor be liable for any direct, indirect, incidental, special, or consequential damages arising out of or in connection with the use of the fonts, whether based on contract, tort, strict liability, or otherwise, even if Licensor have been advised of the possibility of such damages.

#### **6. Termination**

This agreement will automatically terminate if the Licensee fails to comply with any of its terms. Upon termination, the Licensee must cease all use of the fonts and, within a maximum of 30 days from the date of termination, destroy all copies of the fonts in the Licensee's possession.

#### **7. Entire Agreement**

This agreement constitutes the entire agreement between Licensee and Licensor with respect to the use of the fonts and supersedes all prior or contemporaneous understandings and agreements, whether written or oral, regarding such subject matter.

#### **8. Severability**

If any provision of this agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

#### **9. No Waiver**

The failure of Licensor to enforce any right or provision of this agreement shall not be deemed a waiver of such right or provision.

#### **10. Trial Fonts**

Licensor offers trial versions of fonts for evaluation purposes, which are freely available for download. These versions, identified by names like "Altone-Trial" or "Ageo-Personal-Use," may feature an incomplete character set. The trial fonts are intended solely for personal use and evaluation purposes. Any commercial utilization or usage providing economic benefits to users, as well as non-commercial usage reaching large-scale audiences, is strictly prohibited.

#### **11. License Updates**

This font's license terms and provisions may be updated from time to time. Any changes to the terms and provisions of the license will be made available on <https://ekobimantara.com/>. However, these changes do not automatically amend the license agreement that Licensee have previously purchased. Contact Licensor if Licensee would like to obtain or confirm the license that Licensee have purchased.
