

End User License Agreement

Version 1.1 | August 01, 2026

1. License Grant

Subject to the terms of this Agreement, Licensor (Eko Bimantara) grants the Licensee a non-exclusive, non-transferable, perpetual license to use the Font Software according to the license details purchased. This license grants the right to use the Font Software. It does not transfer copyright, ownership, source files, or intellectual property rights to the Licensee.

2. Permitted Uses

This clause granted depends on the purchased license package at ekobimantara.com

2.1 Desktop License

This Desktop License permits the Licensee to install and use the Font Software on desktop or laptop computers up to the number of users specified in the purchased permitted use. Use for unlimited number of users is allowed within the company or company's business affiliate. The Font Software may be used to create static commercial and non-commercial designs, including logos, branding, packaging, printed materials, signage, merchandise, marketing materials, social media graphics, presentations, PDF documents, and other visual artwork.

2.2 Web License

This Web License permits the Licensee to embed the Font Software on websites owned or controlled by the Licensee using supported webfont technologies. Use of the Font Software is limited to the permitted monthly pageviews purchased. The Font Software must remain under the Licensee's control and may not be made available for download, extraction, or redistribution by third parties.

2.3 Digital Ads

This Digital Ads License permits the Font Software to be used in digital advertising campaigns, including display advertisements, banner advertisements, social media advertisements, online marketing campaigns, and similar promotional materials. Use is limited to the maximum advertisement impressions included within the purchased permitted use.

2.4 ePub License

This ePub License permits the Font Software to be embedded within electronic publications, including eBooks, digital magazines, interactive publications, and similar

digital documents. The number of publications permitted shall not exceed the purchased permitted use.

2.5 App License

This App License permits the Licensee to embed the Font Software within mobile applications, desktop software, or other applications owned or distributed by the Licensee. The Font Software may be embedded only in a secure manner that reasonably prevents extraction or redistribution outside the licensed application. Use of the Font Software is specified in the purchased number of applications users.

2.6 Server License

This Server License permits installation of the Font Software on server infrastructure controlled by the Licensee for server-side rendering, automated document generation, dynamic image generation, web-to-print systems, or similar automated services. Installation and use are limited to the permitted use purchased.

2.7 Broadcast License

This Broadcast License permits the Font Software to be used in television programs, commercials, streaming content, motion graphics, and other audiovisual productions distributed within the geographic territory covered by the purchased permitted use.

2.8 Trademark Registration License

This Trademark Registration License permits the Licensee to register a logo or trademark incorporating the licensed Font Software as part of the final design. This license grants permission solely for trademark registration and does not transfer ownership of the Font Software or any associated copyright or intellectual property rights.

3. Restrictions

3.1. All fonts provided remain the intellectual property of Licensor. Therefore, Licensee may not modify, alter, disassemble or rename the font software. This applies also to the code inside the font files.

3.2. The Licensee may not share, resell, sublicense, publicly redistribute Font Software. The Licensee may not allow unlicensed third parties to access the Font Software or use it outside the licensed scope.

3.3. The Font Software may not be used for AI training, dataset creation, or machine-learning model development without separate written permission.

3.4. Licensee may make back-up copies of the fonts for archive purposes only.

3.5. Licensee agree to be careful of the usage of these Font Software. All forms of usage need to be protected from misuse, the font files need to be secured from accessed, extracted or taken by parties which are not related to this agreement.

3.6. If Licensee are a design consultant, agent, or an advertising agency, Licensee must acquire a separate license for each client utilizing the fonts. Additionally, each client, acting as the end user, must obtain a license appropriate for their specific use of the fonts.

4. Warranty of Ownership

Licensor warrants that it owns or holds all necessary rights and authority to license the Font Software under this Agreement and that, to the best of Licensor's knowledge as of the Effective Date of this Agreement, the Font Software does not infringe any valid intellectual property rights of any third party. Except for this limited warranty, the Font Software is provided "AS IS" without any other express, implied, or statutory warranties, including, without limitation, any implied warranties of merchantability, fitness for a particular purpose, or non-infringement.

5. Limitation of Liability

In no event shall Licensor be liable for indirect, incidental, special, or consequential damages arising out of or in connection with the use of the fonts.

6. Termination

This agreement will automatically terminate if the Licensee fails to comply with any of its terms.

7. License Updates

License terms may be updated from time to time, but updates do not automatically amend licenses previously purchased.
